The World Council for Health wishes to support the North Group initiative (See enclosed copy) calling for:

- **An immediate halt to the use of COVID-19 modified mRNA vaccines and a product recall.**
- **An independent and transparent investigation into their approval and use.**
- **Scientific evidence that documents that there is absolutely no risk of damage to human DNA**

The World Council for Health wishes to amplify NORTH Group's message by adding the following revisions and clarifications to the above statements:

- **Due to the well demonstrated harms of these products, there must be an immediate halt to the use of COVID-19 mRNA injections for vaccination or other therapeutic purposes, excepting possibly for research use, and pending the approval of such products by fair and reasonable standards. Due to the well demonstrated harms of these products and the scientifically flawed concept of using systemically administered mRNA for vaccination, we request an immediate moratorium on the use and marketing approval of mRNA 'vaccines', including in domestic animals, other than for research use within suitable containment facilities and under appropriate regulation. The moratorium should extend until complete reproductive and genotoxicity testing, which should have been performed prior to marketing approval, has been performed and pending the approval of such products by fair and reasonable standards, and subject to full public review.**
- **Due to the rushed and non-transparent nature of their development, we call for the creation of a completely and verifiably independent investigating committee, whose inquiry into the development of the so-called COVID-19 vaccine will be completely transparent, and who will thoroughly investigate every aspect of the COVID-19 mRNA vaccine approval process and all data pertaining to their use, especially regarding safety and efficacy. We further call for all members of such a committee to be thoroughly vetted and that there be legal supervision of the process to ensure that any possible violations forthcoming from the investigation be identified and if necessary, rectified legally.**

- **We call for demonstration by an independent committee of investigators that there is clear and convincing evidence that any current, currently being developed, or proposed mRNA injections are safe both for human DNA and for human usage more generally, as measured by clear and verifiable metrics for safety, such as severity, duration, and frequency of any and all adverse effects, and characterization of all DNA effects along with a detailed risk profile for any and all DNA effects identified.**

We fully support the initiative of the North Group in pursuing their above-stated initiatives, along with the clarifications given. World Council for Health is well aware of the massive harms caused by these products and the data showing negative efficacy. It beggars belief that such products could be kept on the market by regulatory agencies created to protect the public from precisely the kinds of harms the evidence so clearly shows these fraudulently advertised products are causing. Notwithstanding the endorsement from media, politicians, public health officials, and other hired guns within academia, the medical profession, and celebrities, the evidence speaks for itself. Not acting upon this evidence is at minimum immoral, and possibly illegal, as a crime of medical neglect. Those who fail to take action on this health crisis will likely be disgraced forever in posterity. Please do not be one of them. Take action now!

We are asking you to do what is right for the safety of the public. Your actions will speak loudly. Public health has lost credibility. It is time to highlight this loss of trust and bring back "real science". We will be monitoring the response of public officials and there will be no surcease to our efforts to hold those responsible accountable, and until our requests are honored.
